

Minutes of Regular Meeting
Mayor and Council

January 14, 2019

Mayor and Council of the City of Fitzgerald, Georgia, met in a **Regular** meeting in the City Hall Council Chambers, located at 302 East Central Avenue, with Mayor Puckett presiding and with Council members Coney, Griffin, Johnson, Jones, Roberts, Tillman, Webb and Williams being present.

Minutes of December 10, 2018, Regular Council meeting were read. Mayor Puckett entertained a motion for approval. Council Person Coney made a motion to approve minutes, seconded by Council Person Griffin. Having a motion and a second, Mayor Puckett asked if there were any additions or corrections. With none being heard, called for a **Roll Call Vote: 8 Yes, 0 No. All in favor, motion approved.**

Minutes of December 27, 2018, Called Council meeting were read. Mayor Puckett entertained a motion for approval. Council Person Coney made a motion to approve minutes, seconded by Council Person Johnson. Having a motion and a second, Mayor Puckett asked if there were any additions or corrections. Mayor Puckett asked if there was any discussion and with none, called for **Roll Call Vote: 8 Yes, 0 No. All in favor. Motion approved.**
