

**Minutes of Regular Meeting
Mayor and Council
City of Fitzgerald, Georgia
January 13, 2020
6:00 pm**

Mayor and Council of the City of Fitzgerald, Georgia, met in a **Regular** meeting in the City Hall Council Chambers, located at 302 East Central Avenue, with Mayor Puckett presiding and with Council members Griffin, Jefferson, J. Johnson, K. Johnson, Peavey, Roberts, and Webb being present.

Minutes of December 9, 2019, Regular Council meeting were read. Mayor Puckett entertained a motion for approval.
