Mayor and Council of the City of Fitzgerald, Georgia, met in a *regular* meeting via teleconference in the City Hall offices, located on the first floor at 302 East Central Avenue, with Mayor Puckett presiding and with Council members Brown, Griffin, D. Jefferson, S. Jefferson, J. Johnson, K. Johnson, Peavey, Roberts, and Webb being present. The call also included Tim Anderson and City Attorney Kyle Cook.
