

**Minutes of Regular Meeting**

Mayor and Council of the City of Fitzgerald, Georgia, met in a **Teleconference** meeting in the City Hall conference room, located at 302 East Central Avenue, with Mayor Puckett presiding and with Council members Brown, Griffin, D.
