

**Minutes of Regular Meeting  
Mayor and Council  
City of Fitzgerald, Georgia  
March 9, 2020

Mayor and Council of the City of Fitzgerald, Georgia, met in a **Regular** meeting in the City Hall Council Chambers, located at 302 East Central Avenue, with Mayor Puckett presiding and with Council members Brown, Griffin, D. Jefferson, S. Jefferson, J. Johnson, K. Johnson, Peavey, Roberts, and Webb being present.

Minutes of February 10, 2020, Regular Council meeting were read. Mayor Puckett entertained a motion for approval.

Reports of standing committees was given by the respective chairperson.

Mayor Puckett called on City Attorney, Kyle Cook, to present the following ordinances and resolutions:

Mr. Cook presented the following Ordinance Captions:

- An ordinance to amend the zoning ordinance of the City of Fitzgerald, Georgia, as adopted February 13, 1989 and readopted by Ordinance number 1122 on April 10, 1989, specifically to provide for regulation of solar electrical systems.
- An ordinance to close to vehicular and pedestrian traffic a portion of that certain public road known as North Point Drive and North Point Lane in the City of Fitzgerald, Ben Hill County, Georgia.
- An ordinance to close permanently for all purposes that portion of the public alley that lies adjacent to and East and South of Lot 4 in Farris Grove Subdivision, in land lot 92 in the third land district in the City of Fitzgerald, Georgia, Ben Hill County, Georgia.
- An ordinance to close to vehicular traffic that portion of the public alley between city lots 8, 9, 10, 11, 12, 13, and 14 and city lots 22, 23, 24, 25, 26, 27, and 28 in square 1, block 11, in the City of Fitzgerald, Georgia.

Mr. Cook presented the following Resolution:

**Resolution R20-007:** A **Resolution** to authorize an agreement between the City of Fitzgerald, Georgia and the Board of Commissioners of Ben Hill County, Georgia, to provide funding for the

operation of the Department of Leisure Services pool facility for the 2020 season and for reduction of participation fees.

**Second:** J. Johnson


